Release of Security Interest in Trademark

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK ("Release") is made as of the 1st day of January, 2014, by PNC BANK, NATIONAL ASSOCIATION, as Administrative Agent (the "Administrative Agent").

RECITALS

Pursuant to that certain First Amended and Restated Security Agreement dated as of April 11, 2012 (as the same may have been amended, modified, extended or restated from time to time, the "Security Agreement") by and among the Haines & Kibblehouse, Inc. ("Pledgor") and others for the benefit of the Administrative Agent and other Secured Parties referenced therein, the Pledgor granted to the Administrative Agent for the ratable benefit of the Secured Parties a continuing security interest in and to the trademark shown below ("Trademark"):

NOW, THEREFORE, in accordance with the Security Agreement, and in consideration of good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Administrative Agent agrees as follows:


1. Release. The Administrative Agent hereby releases its security interests in and liens on the Trademark.


