RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the "Release") is made effective as of February 13, 2014, by GENERAL ELECTRIC CAPITAL CORPORATION, as Agent (the "Agent") to SPTC, INC. and such additional Sotheby Entities as defined in the Credit Agreement (each such Person individually referred to herein as "Grantor" and collectively the "Grantors") as follows:

WHEREAS, the Grantors and the Agent for the Secured Parties are parties to that certain U.S. Security Agreement dated as of August 31, 2009 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors were required to execute and deliver a Trademark Security Agreement dated as of August 31, 2009 and Supplemental Trademark Security Agreements dated as of March 29, 2012 and December 19, 2012 (collectively the "Trademark Agreements") to the Agent in order to secure the prompt and complete payment, observance and performance of all of the Secured Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to the Trademark Agreements, the Grantors granted to the Agent, among other collateral, a continuing security interest in all of the Grantors' right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Marks");

WHEREAS, the Trademark Agreements were recorded in the United States Patent & Trademark Office on August 31, 2009 at Reel/Frame 4054/0550, March 30, 2012 at Reel/Frame 4749/0636, and December 21, 2012 at Reel/Frame 4927/0393; and


WHEREAS, the Agent wishes to release its security interest in the Marks.

NOW THEREFORE, as the Grantors have satisfied its Secured Obligations under the Security Agreement, the Agent hereby terminates, releases and discharges any security interest in and lien upon the Marks, and assigns, transfers, and conveys to the Grantors any and all right, title or interest in, or to, the Marks that the Agent may hold.
