Pursuant to the provisions of Section 14-2-1105 and Section 14-2-1107 of the Georgia Business Corporation Code ("GBCC"), the undersigned business entity does hereby certify as follows:

1. The name and state of incorporation of each corporation which is merging is as follows:
  - (i) Radiant Systems, Inc., a Georgia corporation ("Radiant"); and
  - (ii) NCR Corporation, a Maryland corporation ("NCR").

Radiant shall be merged with and into NCR, with NCR being the surviving corporation. The name of the surviving corporation is NCR Corporation.

2. The articles of incorporation of NCR, as in effect immediately before the merger shall be the articles of incorporation of the surviving corporation.

3. An Agreement and Plan of Merger (the "Merger Agreement") has been approved and adopted by each of the aforesaid corporations in accordance with the requirements of the laws of Georgia and Maryland. The executed Merger Agreement between the aforesaid corporations is on file at the place of business of the surviving corporation, the address of which is as follows:

6. The request for publication of a notice of filing of this Certificate of Merger and payment therefor will be made as required by Section 14-2-1105.1 of the GBCC.
7. The merger shall be effective at 11:00 p.m. Eastern time on December 31, 2013.


