## **RELEASE OF FIRST LIEN TRADEMARK SECURITY AGREEMENT**

**THIS RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “Release”) is made as of February 28, 2014 (the “Effective Date”), by Bank of America, N.A., as collateral agent (in such capacity, the “Collateral Agent”), in favor of Sedgwick Claims Management Services, Inc., CompManagement, Inc. and CMI Octagon, Inc. (collectively, the “Pledgors”).

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement between the Pledgors and the Collateral Agent dated as of May 28, 2010 (the “Trademark Security Agreement”), the Pledgors pledged and granted to the Collateral Agent a lien on and security interest in all of their rights, titles and interests in and to certain collateral identified in said Trademark Security Agreement set forth on Schedule I hereto including, without limitation, the goodwill associated therewith (collectively, the “Trademarks”);

**WHEREAS**, the Trademark Security Agreement was recorded with the Assignment Division of the U.S. Patent & Trademark Office on June 14, 2010, at Reel 4223 and Frame 0894;


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the Trademarks arising under the Trademark Security Agreement.

If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Trademarks, it hereby irrevocably re-assigns and re-transfers all such rights, title and interest to the Pledgor.

The Collateral Agent shall take all further actions, and provide to the Pledgor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgor, and at Pledgor’s cost and expense, to more fully and effectively effectuate the purposes of this Release.
