## ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment of Intellectual Property (this "Assignment") is made this 10th day of February, 2014, by NextMedia Group, Inc., a Delaware corporation, and NextMedia Operating, Inc., a Delaware corporation (collectively, the "Assignors"), and Digits Companies, LLC, a Delaware limited liability company ("Assignee").

WHEREAS, NextMedia Group, Inc., The Mile High Station Trust, LLC, Assignee and Palm Beach Broadcasting, LLC are parties to that certain Asset Purchase Agreement, dated as of October 8, 2013 (the "Purchase Agreement"), pursuant to which Assignors have agreed to sell, convey, transfer, assign and deliver to Assignee all of their right, title and interest in, to the Business Intellectual Property (as defined in the Purchase Agreement) primarily relating to the NextMedia Business (the "Assigned IP");

WHEREAS, Assignee wishes to acquire all of Assignors' right, title and interest in and to the Assigned IP, and Assignors wish to assign same to Assignee; and

NOW, THEREFORE, in accordance with the foregoing, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors hereby assign, sell and transfer unto Assignee, its successors and assigns, all of their right, title and interest, throughout the world in perpetuity, including common law rights, in and to the Assigned IP, together with the goodwill associated therewith and the entire Business and/or portion thereof to which the Assigned IP pertain, and the right to sue and recover for all past, present and future infringements and other violations of the Assigned IP, the same to be held and enjoyed by Assignee, its successors and assigns to the same extent that such would have been held and enjoyed by Assignors had this assignment not been made. Assignors hereby covenant and agree to provide any further necessary documentation and perform further acts reasonably requested by Assignee necessary to confirm and perfect title in and to the Assigned IP in Assignee, each at Assignee's cost and expense.

This Assignment is intended to evidence the consummation of the transactions contemplated by the Purchase Agreement and is subject to the terms and conditions set forth in the Purchase Agreement. This Assignment is made without representation or warranty, except as provided in and by the Purchase Agreement. Nothing contained in this Assignment shall be construed to supersede, limit or qualify any provision of the Purchase Agreement. To the extent there is a conflict between the terms and provisions of this Assignment and the terms and provisions of the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern.

The parties agree that (i) to the extent this Assignment is structured as an agreement or instrument between MHST Seller and Matrix (or any of its Affiliates) the conveyance by MHST Seller directly to Matrix (or any of its Affiliates) is being effected purely for the administrative convenience of Assignee, (ii) under no circumstances will Matrix (or any of its Affiliates) acquire any rights against MHST Seller by virtue of the execution and delivery of this Assignment or the direct conveyance of any MHST Assets or MHST Obligations to

Matrix (or any of its Affiliates) and (iii) all claims made by Matrix (or any of its Affiliates) with respect to the MHST Assets and MHST Obligations shall be made against Assignee.

The construction and performance of this Assignment shall be governed by the laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule that would cause the application of Laws of any jurisdiction other than the State of Delaware.

This Assignment shall be binding upon, and inure to the benefit of, the parties hereto and their respective successors in interest. This Assignment may not be assigned by any of the parties hereto.






