## RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST

This **RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST**, dated as of February 28, 2014 (the "Release"), is made by **BNP Paribas**, as Administrative Agent (in such capacity, the "Secured Party") for the Lenders, in connection with the termination of that certain Grant of Trademark Security Interest (the "Grant of Trademark Security Interest"), dated as of November 1, 2012, made by the **Dexter Axle Company** ("Grantor") in favor of the Secured Party. WHEREAS, the Secured Party acknowledges full payment, complete performance and satisfaction of all obligations secured by the Grant of Trademark Security Interest;

WHEREAS, the Grantors have requested that the Secured Party release its security interest in the Trademark Collateral in connection with the termination of the Grant of Trademark Security Interest (the "Released Collateral").


