## REASSIGNMENT AND RELEASE OF SECURITY INTEREST - TRADEMARKS

This Reassignment and Release of Security Interest – Trademarks (this “Release”) is made as of February 28, 2014 by PNC Bank, National Association (“PNC”), in its capacity as agent (PNC in such capacity, “Agent”) for itself and the various other financial institutions (collectively, the “Lenders”) party from time to time to that certain Revolving Credit, Term Loan and Security Agreement dated as of July 10, 2012, as amended (the “Credit Agreement”), with ETX Holdings, Inc., a Delaware corporation, ETX, Inc., a Delaware corporation, Alma Products I, Inc., a Delaware corporation, Dacco, Incorporated, an Ohio corporation, ATCO Products, Inc., a Delaware corporation, Michigan Equipment Corporation, a Delaware corporation, and each of the other Subsidiary Borrowers (as defined in the Credit Agreement) party to the Credit Agreement (collectively, the “Companies”).

### Recitals

1. In connection with the Credit Agreement, the Companies executed and delivered to Agent that certain Intellectual Property Security Agreement dated as of July 10, 2012 (the “Intellectual Property Security Agreement”, and together with the Credit Agreement, the “Security Agreement”).

2. Pursuant to the Security Agreement, the Companies pledged, assigned and granted to Agent, a security interest in the trademark and trademark applications identified on Schedule 1 to this Release (collectively, the “Trademarks”).

3. The Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 4827/0746 on July 24, 2012.

4. The Agent wishes to reassign to the Companies and release all interest that Agent may have in the Trademarks.

### Agreement

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates, releases and discharges any and all security interests in the Trademarks, and reassigns to the Companies, without recourse, representation or warranty, all interest of Agent in the Trademarks.
