RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of February 21, 2014 granted by Deutsche Bank Trust Company Americas, in its capacity as collateral agent pursuant to the First Lien Credit Agreement (in such capacity, the "Collateral Agent") dated as of June 15, 2007, as amended (as amended, amended and restated, supplemented or otherwise modified from time to time, the "First Lien Credit Agreement"), by and among IntraLinks Holdings, Inc. (as successor to TA Indigo Holding Corporation) ("Holdings"), IntraLinks, Inc. (the "Borrower"), each lender from time to time party thereto (collectively, the "Lenders" and individually, a "Lender"), Deutsche Bank Trust Company Americas, as Administrative Agent (in such capacity, "Administrative Agent"), collateral agent and syndication agent and the other agents and arrangers named therein.

WHEREAS, pursuant to the terms and conditions of that certain First Lien Trademark Security Agreement, dated as of June 15, 2007, by and among the Borrower (the "Pledgor") and the Collateral Agent (the "First Lien Security Agreement"; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the First Lien Security Agreement), the Pledgors granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to the Trademarks including, without limitation, the Trademark registrations and applications set forth on Schedule I hereto (collectively, the "Trademarks");

WHEREAS the First Lien Security Agreement relating to the Trademarks has been recorded with the Assignments Division of the U.S. Trademark and Trademark Office on June 22, 2007 at Reel 003566 and Frame 0506; and

WHEREAS the Pledgor has paid all of its outstanding indebtedness under the First Lien Credit Agreement which is secured by the First Lien Security Agreement and has requested that the Collateral Agent release its security interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the First Lien Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks, without warranty or recourse.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Pledgor.


This Release shall be construed in accordance with and governed by the law of the State of New York.
