## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of March 25, 2014, by Citibank, N.A., London Branch, a United Kingdom bank located at Citigroup Centre, 25 Canada Square, London, United Kingdom, E12 5LB, in its capacity as Security Agent ("Security Agent") for each of the Secured Parties, in favor of ESSELTE CORPORATION, a New York corporation located at 225 Broadhollow Road, Suite 300, Melville, New York 11747, and AMERICAN PAD & PAPER LLC, a Delaware limited liability company located at 3101 E. President George Bush Freeway, Suite 200, Richardson, Texas 75082 (each, a "Grantor" and, together, the "Grantors"). All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Security Agreement, dated as of August 28, 2012 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement"), among, *inter alios*, the Grantors and the Security Agent.

WHEREAS, reference is made to the Term Loan Facility Agreement, dated June 7, 2010 (as amended and restated on December 20, 2010, as further amended and restated on August 28, 2012, as further amended on August 12, 2013 and as otherwise amended, supplemented, or modified prior to the date hereof, the "Credit Agreement"), among, *inter alios*, the Grantors, the Lenders (as defined therein) and the Security Agent;

WHEREAS, pursuant to (i) the Security Agreement and (ii) a Trademark Security Agreement dated as of August 28, 2012 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), each Grantor unconditionally granted, assigned and pledged to the Security Agent, for the benefit of the Secured Parties, to secure the Secured Obligations, a continuing security interest in all of such Grantor's right, title and interest in and to the following, whether then owned or thereafter acquired or arising (collectively, the "Trademark Collateral"):

- (a) all of its Trademarks and Trademark Intellectual Property Licenses to which it is a party, including those referred to on Schedule A hereto;
- (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and
- (c) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License except to the extent that such Intellectual Property License is an Excluded Asset; and

WHEREAS, the Trademark Security Agreement was recorded on September 6, 2012 with the United States Patent and Trademark Office under Reel and Frame number 4854/0915.

NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent agrees as follows:

- (a) Security Agent, on behalf of the Secured Parties, hereby terminates, relinquishes, releases and discharges fully its security interest in and to the Trademark Collateral.
- (b) Security Agent hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other applicable government officer record this Release.
- (c) This Release shall be governed by, and construed in accordance with the law of the State of New York.

For the avoidance of doubt, this Release is granted only as to the Grantors and their right, title and interest in the Trademark Collateral. The Credit Agreement, the Security Agreement and the Trademark Security Agreement remain in effect as to the other grantors thereunder and the continuing security interest of the Security Agent in the property of such other grantors is not affected by this Release.
