INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "Agreement") is entered into as of January 11, 2012 by and among EAST WEST BANK ("Bank"), SENDORI, INC., a Delaware corporation; SENDORI HOLDINGS, INC., a Delaware corporation; SSL ASSETS, LLC, a Delaware limited liability company (collectively, "Grantor").

RECITALS

Bank and Grantor propose to enter into that certain Loan and Security Agreement dated as of the date hereof (the "**Loan Agreement**", as may be amended from time to time). Capitalized terms used but not defined herein have the meaning assigned in the Loan Agreement.

NOW, THEREFORE, Grantor agrees as follows:

AGREEMENT

To secure performance of Grantor's obligations under the Agreement, Grantor grants to Bank a security interest in all of Grantor's right, title and interest in Grantor's intellectual property whether presently existing or hereafter acquired (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C hereto), including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits). This security interest is granted in conjunction with the security interest granted to Bank in the Agreement.

This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument.




