RELEASE OF SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of January 2, 2013 (the "Effective Date") by Bank of America, N.A., as collateral agent (in such capacity, the "Agent") for the benefit of ARDENT MEDICAL SERVICES, INC. and AHS OKLAHOMA HEART, LLC (together, the "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Notice of Grant of Security Interest in Trademarks, dated as of March 15, 2010 (the "Security Agreement"), between the Grantors and the Agent, the Grantors pledged, assigned and granted to the Agent a continuing security interest in all of its right, title and interest in and to certain collateral including, without limitation, the trademark registrations and applications set forth on Schedule I hereto along with the goodwill associated therewith (collectively, the "Trademarks");

WHEREAS, the Security Agreement was recorded with the U.S. Patent & Trademark Office on March 16, 2010, at Reel 004167 and Frame 0473;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks.

If and to the extent the Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to their respective Grantors.

The Agent shall take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release.


