**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of April 16, 2014 (“Effective Date”) by BANK OF AMERICA, N.A. (the “Administrative Agent”) in favor of OmniGen Research, LLC (“Pledgor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

**WHEREAS**, the Pledgor is a party to that certain Security Agreement dated August 31, 2010 (as amended, restated or otherwise modified from time to time, the “Security Agreement”) in favor of the Administrative Agent;

**WHEREAS**, Pledgor and Administrative Agent entered into that certain Trademark Security Agreement dated January 18, 2013 (the “Trademark Security Agreement”), to record the continuing security interest in all right, title and interest of the Pledgor in, to and under the trademarks and service marks listed on the annexed Schedule 1 (the “Trademarks”), together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the “Trademark Collateral”), and such Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 2, 2013, at Reel 004973, Frame 0852; and

**WHEREAS**, Pledgor requests a specific release of the security interest granted and recorded against the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby, on behalf of itself and the Secured Parties, terminates the Trademark Security Agreement and releases and re-assigns to Pledgor any and all liens, security interests, right, title and interest it may have in, to and under the Trademark Collateral, together with the goodwill of the business symbolized thereby.

This Release may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
