TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT dated as of April 22, 2014, by WELLS FARGO BANK, NATIONAL ASSOCIATION (the "Secured Party").

WHEREAS, TRINITY GLASS INTERNATIONAL, INC., a Washington corporation (the "Grantor") and the Secured Party entered into a Patent and Trademark Security Agreement, dated as of April 24, 2009 (the "Security Agreement") which Security Agreement was recorded with the United States Patent and Trademark Office on July 30, 2009, at Reel 004034, Frame 0751 for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Credit Agreement (as defined in the Security Agreement);

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Intellectual Property as herein provided:

NOW, THEREFORE, for valuable consideration the Secured Party hereby terminates and releases its security interest in the Intellectual Property, including without limitation the Trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Intellectual Property, effective as of the date set forth above.

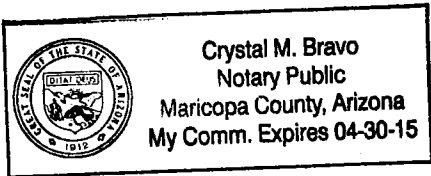
