RELEASE OF GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of May 15, 2014 (the "Release"), is made by Royal Bank of Canada, as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties, in connection with the release of certain Grantors party to that certain Intellectual Property Security Agreement (the "IP Security Agreement"), dated as of July 30, 2010, made by the Grantors party thereto in favor of the Collateral Agent. All capitalized terms used in this Release and not otherwise defined herein shall have the meanings assigned to them in the IP Security Agreement.

WITNESSETH

WHEREAS, pursuant to the IP Security Agreement, each Grantor granted to the Collateral Agent, for the benefit of the Collateral Agent and the ratable benefit of the Secured Parties, a continuing security interest in and first priority lien on all of Grantor's rights, title and interests in certain intellectual property, including the intellectual property referred to on Schedule A hereto (the "Pledge");

WHEREAS, the Collateral Agent acknowledges each Grantor specified on Schedule A has been released from (i) its obligations under the Loan Documents and (ii) all security interests, mortgages, encumbrances, pledges and other Liens, including the Pledge, granted by such Grantor in favor of the Collateral Agent for the benefit of the Secured Parties under any Loan Document;


WHEREAS, each Grantor specified on Schedule A has requested that the Collateral Agent release its security interest in the intellectual property specified on Schedule A (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby releases, all of its security interest in the Released Collateral.

The Secured Party agrees to, at its request, provide each Grantor specified on Schedule A with any information and additional authorization reasonably necessary to effect the release of its security interest in the Released Collateral at the sole expense of such Grantor. The Collateral Agent authorizes each Grantor, or its designee, to file this Release for recording with the United States Patent and Trademark Office, United States Copyright Office and other governmental authorities, as applicable.
