This RELEASE OF TRADEMARK SECURITY INTEREST ("Release") dated May 14, 2014, is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, as Administrative Agent under the Credit Agreement referred to below, a bank national association with its principal office at 50 South Sixth Street, Suite 1290, Minneapolis, MN 55402 for the Secured Parties (as defined in the Credit Agreement referred to below) (the "Agent"), in favor of KURYAKYN HOLDINGS, LLC, a Delaware limited liability company located at 454 County Road 35/64, Somerset, WI 54025, J&P CYCLES, LLC, a Delaware limited liability company located at 13225 Circle Drive, PO Box 138, Anamosa, IA 52205, DFR ACQUISITION **CORPORATION**, a Delaware corporation located at 3191 N. Washington St., Ste. 2, Chandler, AZ 85525, MOTORSPORT AFTERMARKET GROUP, INC., a Delaware corporation located at 17771 Mitchell North, Irvine, CA 92614, MUSTANG MOTORCYCLE **PRODUCTS, LLC**, a Delaware limited liability company located at 65 Springfield Street, Palmer, MA 01069, PERFORMANCE MACHINE, LLC, a Delaware limited liability company located at 6892 Marlin Circle, La Palma, CA 90623, PROGRESSIVE SUSPENSION, LLC, a Delaware limited liability company located at 6911 Marlin Circle, La Palma, CA 90623, and V&H PERFORMANCE, LLC, a Delaware limited liability company located at 13861 Rosecrans Avenue, Santa Fe Springs, CA 90670, (each, a "Grantor" and, collectively, the "Grantors").

Reference is made to the Credit Agreement, dated as of March 26, 2012 (as amended, restated, amended and restated, extended, refinanced, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among Motorsport Aftermarket Group, Inc., a Delaware corporation, as the Borrower ("Borrower"), Rally Holdings, LLC, a Delaware limited liability company ("Holdings"), Ralco Holdings, Inc., a Delaware corporation, the other Persons listed as "Loan Parties" on the signature pages thereto, as Guarantors, the Lenders party thereto from time to time and the Agent.

WHEREAS, as a condition precedent to the Lenders' extension of such credit, each Grantor executed and delivered to the Agent (i) a Security Agreement dated as of March 26, 2012, (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), (ii) a Trademark Security Agreement, dated as of March 26, 2012, which was recorded in the United States Patent and Trademark Office on February 25, 2013 at Reel 4969/Frame 0806, and (iii) a Trademark Security Agreement, dated as of March 26, 2012, which was recorded in the United States Patent and Trademark Office on February 25, 2013 at Reel 4969/Frame 0835 (together with (ii), the "Trademark Security Agreements"), and

WHEREAS, under the terms of the Security Agreement and the Trademark Security Agreements, the Grantors granted to the Agent, and its successors and assigns, for the benefit of the Secured Parties, a continuing security interest in, among other property, all of their respective right, title and interest in, to and under the Trademarks, including the Trademarks set forth on Schedule A attached hereto; provided, that, no security interest was granted in any "intent-to-use" application for registration of a Trademark filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C § 1051, prior to the filing of a "Statement of Use" pursuant to Section 1(d) of the

Lanham Act or an "Amendment to Allege Use" pursuant to Section 1(c) of the Lanham Act with respect thereto, to the extent that, and during the period, if any, in which, the grant of a security interest therein would have impaired the validity or enforceability of any registration that issues from such intent-to-use application under applicable federal law (it being understood that after such period such intent-to-use application was automatically subjected to the security interest granted therein), and

**WHEREAS**, the secured obligations have been paid and performed in full and the Agent desires to document its release of its continuing security interest in the Trademarks which was granted under the Security Agreement and the Trademark Security Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

- 1. <u>Terms</u>. Terms defined in the Credit Agreement, the Security Agreement and the Trademark Security Agreement not otherwise defined herein are used herein as defined in the Credit Agreement, the Security Agreement, and the Trademark Security Agreements, as applicable.
- 2. <u>Release of Security Interest</u>. The Agent hereby terminates and releases, in its entirety, for the benefit of the Grantors, and their successors and assigns to the Trademarks, the **Agent's** continuing security interest in all of the **Grantors'** right, title and interest in, to and under the Trademarks, including the Trademarks set forth on <u>Schedule A</u> hereto.
- 3. <u>Recordation</u>. The Agent authorizes and requests that the Commissioner for Trademarks record this Release.
- 4. <u>Delivery by Facsimile</u>. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release.
- 5. <u>Further Assurances</u>. From time to time after the date hereof, upon any **Grantor's** reasonable request, the Agent shall execute all other documents and instruments reasonably necessary to fully terminate and release **the Agent's** security interest in all of the **Grantors'** right, title and interest in to and under and to the Trademarks, including, but not limited to, releases, assignments, powers of attorney, or other instruments in recordable form as are necessary or desirable to make effective the release herein made.
