RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

WHEREAS, the Security Agreement was recorded in the United States Patent & Trademark Office on October 25, 2011 at Reel/Frame 4648/0242; and


WHEREAS, the Secured Party wishes to release its security interest in the Mark.
