NOTICE OF RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTERESTS IN TRADEMARKS, dated as of May 16, 2014, is given by DEUTSCHE BANK TRUST COMPANY AMERICAS (the "*Collateral Agent*") pursuant to a Trademark Security Agreement (as amended, modified or supplemented, the "*Security Agreement*") dated as of September 30, 2013 between OUTBACK STEAKHOUSE OF FLORIDA, LLC (the "*Grantor*") and the Collateral Agent.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, a security interest (the "*Security Interest*") was granted by the Grantor to the Collateral Agent in the Trademark Collateral (as hereinafter defined); and

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office on November 6, 2013 at **Reel 5148, Frame 0432**; and

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:


1. Definitions. The term "*Trademark Collateral*", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Marks (as defined in the Security Agreement), including, without limitation, those items listed on Schedule I hereto.




