NOTICE OF RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTERESTS IN TRADEMARKS, dated as of May 16, 2014, is given by DEUTSCHE BANK TRUST COMPANY AMERICAS (the "*Collateral Agent*") pursuant to a Trademark Security Agreement (as amended, modified or supplemented, the "*Security Agreement*") dated as of September 30, 2013 between OS MANAGEMENT, INC. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:






