## NOTICE OF RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTERESTS IN TRADEMARKS, dated as of May 16, 2014, is given by DEUTSCHE BANK TRUST COMPANY AMERICAS (the "*Collateral Agent*") pursuant to a Trademark Security Agreement (as amended, modified or supplemented, the "*Security Agreement*") dated as of June 30, 2013 between OS MANAGEMENT, INC. 1. Definitions. The term "*Trademark Collateral*", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Marks (as defined in the Security Agreement), including, without limitation, those items listed on Schedule I hereto.

2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral without representation, warranty or recourse of any kind or nature.
