**INTELLECTUAL PROPERTY LIEN TERMINATION AND ASSIGNMENT AND  
ASSUMPTION AGREEMENT**

This INTELLECTUAL PROPERTY LIEN TERMINATION AND ASSIGNMENT AND ASSUMPTION AGREEMENT, dated as of May 23, 2014 (this "Assignment"), is made and entered into by and among Special Event Holding, Inc., a Delaware corporation, Event Rentals, Inc., a Delaware corporation, Dubo Acquisition Corporation, a Delaware corporation, DBO Acquisition Corporation, a Delaware corporation, Classic Party Rentals LP, a Texas limited partnership, Classic Party Rentals, Inc., a California corporation, Classic Midwest, Inc., a Delaware corporation, Classic Northeast, Inc., a Delaware corporation, Classic Panache, Inc., a Delaware corporation, Classic/Prime, Inc., a Delaware corporation, Classic Southeast, Inc., a Delaware corporation, Unique Tabletop Rentals, Inc., a California corporation, and Grand Events and Party Rentals, Inc., a Tennessee corporation (collectively, the "Sellers"), Ableco Finance, LLC, a Delaware limited liability company, as administrative agent for the DIP Lenders (as defined herein) (the "DIP Agent") under the DIP Financing Agreement (as defined herein), and CP OpCo, LLC, a Delaware limited liability company (the "Buyer"). The DIP Agent, Sellers and Buyer are sometimes herein referred to collectively as the "Parties" and individually as a "Party."

WHEREAS, Sellers and Buyer entered into that certain Asset Purchase Agreement dated as of April 28, 2014 (the "Asset Purchase Agreement");

WHEREAS, Sellers desire to sell, convey, assign, transfer and deliver to Buyer the Purchased Intellectual Property, including, without limitation, all copyrights, trademarks, and domain names (including applications therefor) listed on Schedule A attached hereto, in accordance with the Asset Purchase Agreement;

WHEREAS, Sellers are party to that certain Senior Secured and Superpriority Financing Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "DIP Financing Agreement"), dated as of February 18, 2014, by and among Event Rentals, Inc., as borrower, Special Event Holding, Inc. and the other guarantors from time to time party thereto, as guarantors, the financial institutions from time to time party thereto, as lenders (the "DIP Lenders"), and the DIP Agent, pursuant to which Sellers granted Liens, claims, interests and encumbrances with respect to the Purchased Intellectual Property to the DIP Agent (on behalf of the DIP Lenders);

WHEREAS, pursuant to the Sale Order, dated April 29, 2014 entered by the United States Bankruptcy Court for the District of Delaware (the "Sale Order"), among other things, the sale under the Asset Purchase Agreement was approved; and

WHEREAS, pursuant to the Sale Order, the Liens, claims, interests and encumbrances (other than Liens specifically assumed by Buyer under the Asset Purchase Agreement and Permitted Exceptions) on the Purchased Intellectual Property are released and terminated, as of the Closing Date.

NOW, THEREFORE, in consideration of the covenants and agreements contained herein and in the Asset Purchase Agreement, and other good and valuable

consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Parties agree as follows:

1. Release and Termination of Liens. The DIP Agent hereby acknowledges and agrees that it has no Liens, claims, interests and encumbrances in any of the Purchased Intellectual Property and such Liens, claims, interests and encumbrances in the Purchased Intellectual Property have been released and terminated, effective as of the Closing Date.

2. Assignment and Assumption. Sellers hereby sell, convey, assign, transfer and deliver to the Buyer, and Buyer hereby accepts the sale, conveyance, assignment, transfer and delivery of, all of Sellers' right, title and interest in and to the Purchased Intellectual Property, including those listed on Schedule A attached hereto, and all goodwill appurtenant thereto.

3. Effectiveness. This Assignment shall be effective as of the Closing.

4. Terms of the Asset Purchase Agreement. Capitalized terms used but not defined herein shall have the meanings given to such terms in the Asset Purchase Agreement. This Assignment is in accordance with and is subject to all of the terms and conditions of the Asset Purchase Agreement. Nothing contained in this Assignment shall be deemed to supersede, enlarge on, modify or amend any of the obligations, agreements, covenants or warranties of Sellers or Buyer contained in the Asset Purchase Agreement. In the event of any conflict or inconsistency between this Assignment and the Asset Purchase Agreement, the terms of the Asset Purchase Agreement shall prevail.

5. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware applicable to contracts made and performed in such State, except to the extent that such Laws are superseded by the Bankruptcy Code.

6. Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and permitted assigns. Nothing in this Assignment shall create or be deemed to create any third party beneficiary rights in any Person or entity not a Party.

7. Counterparts. This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will be deemed to constitute one and the same agreement.

8. Entire Agreement. This Assignment (together with the Asset Purchase Agreement) constitutes the entire agreement and understanding of the DIP Agent, Buyer and Sellers with respect to the matters contemplated by this Assignment and supersedes any previous agreement among the DIP Agent, Buyer and Sellers in relation to such matters.
