**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

WHEREAS **KISSNER MILLING COMPANY**, an Ontario corporation with principal offices at 32 Cherry Blossom Road, Cambridge, Ontario N3H 4R7 Canada, **THE DETROIT SALT COMPANY, L.C.**, a Michigan limited liability company with principal offices at 12841 Sanders Street, Detroit Michigan 48217, **KISSNER USA INC.**, a Delaware corporation with principal offices at 32 Cherry Blossom Road, Cambridge, Ontario N3H 4R7 Canada, **MAGCO INCORPORATED**, a New York corporation with principal offices at 32 Cherry Blossom Road, Cambridge, Ontario N3H 4R7 Canada, **KISSNER USA HOLDINGS INC.**, a Delaware corporation with principal offices at 32 Cherry Blossom Road, Cambridge, Ontario N3H 4R7 Canada, and **KISSNER CANADA HOLDINGS INC.**, an Ontario corporation with principal offices at 32 Cherry Blossom Road, Cambridge, Ontario N3H 4R7 Canada (collectively, the “Grantors”), entered into a certain Patent, Trademark and Copyright security agreement dated August 9, 2013 (the “IP Security Agreement”) with **PNC BANK, NATIONAL ASSOCIATION**, with principal offices at 249 Fifth Avenue, Pittsburgh, Pennsylvania 15222 (the “Administrative Agent”), notice of which was recorded on August 13, 2013 at the United States Patent and Trademark Office at Reel 5090, Frame 0637.

WHEREAS, Grantors granted the Administrative Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to certain of Grantors’ intellectual property, including without limitation the trademarks listed in Schedule A (collectively, the “Trademarks”) and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as well as all proceeds and claims based on past, present, or future infringement.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the intellectual property of the Grantors, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to the Grantors any interest in such intellectual property, including the Security Interest and any other liens. The Administrative Agent further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantors and their successors and assigns in association with the Security Interest, and hereby releases the Grantors and their successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
