GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

May 22, 2014

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, each of 2414395 ONTARIO INC., an Ontario corporation having a principal place of business at 6789 Airport Road, Mississauga, Ontario, L4V 1N2 ("Forsyth Canada") and FORSYTH U.S. ACQUISITION COMPANY INC., a Delaware corporation having a principal place of business at 545 Fifth Avenue, 5<sup>th</sup> Floor, New York, New York 10017, ("Forsyth U.S." and together with Forsyth Canada, collectively, the "Grantors"), hereby grant to SALUS CAPITAL PARTNERS, LLC, a Delaware limited liability company with its principal office at 197 First Avenue, Suite 250, Needham, Massachusetts 02494, as lender (the "Grantee"), a continuing security interest in (i) all of each Grantor's right, title and interest in, to and under to the trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT is made to secure the satisfactory performance and payment of (i) all of the Obligations of Forsyth Canada, as such term is defined in the General Security Agreement by Forsyth Canada in favour of the Grantee dated as of the date hereof, and (ii) all of the Secured Obligations of Forsyth U.S., as such term is defined in the Security Agreement by and between Forsyth U.S. and the Grantee dated as of the date hereof (collectively, as amended, restated, supplemented or otherwise modified and in effect from time to time, the "Security Agreements"). The Grantors authorize the Commissioner for Trademarks and any other


government officials to record and register this agreement upon request by the Grantee. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreements, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreements, the provisions of the Security Agreements shall govern. This agreement may be executed in counterparts, each of which shall constitute an original, but all of which when taken together shall constitute a single contract.




