## PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST

This Partial Release of Trademark Security Interest ("Partial Release") is made effective as of June 2, 2014 by PNC Bank, National Association (the "Administrative Agent") for itself and as the Administrative Agent for the Lenders to Devin International, Inc., formerly known as Devin Rental Tools, Inc. ("Devin International"), as follows:

WHEREAS, pursuant to that certain Amended and Restated Credit Agreement, dated as of August 8, 2008, that certain Second Amended and Restated Credit Agreement, dated as of January 31, 2011, and that certain Third Amended and Restated Credit Agreement, dated as of June 22, 2012 (collectively, the "Credit Agreements"), the Credit Agreements all by and among Greene's Energy Group, LLC, a Texas limited liability company (the "Borrower"), Devin International, the Guarantors from time to time party thereto, the Lenders from time to time party thereto (the "Lenders"), and the Administrative Agent, the Administrative Agent and the Lenders agreed to provide certain loans to the Borrower, and Devin International agreed, among other things, to grant a security interest to the Administrative Agent in certain trademarks as security for such loans and other obligations;

WHEREAS, pursuant to said Credit Agreements, the Administrative Agent and Devin International entered into that certain Amended and Restated Patent, Trademark and Copyright Security Agreement, dated as of August 8, 2008, that certain Second Amended and Restated Patent, Trademark and Copyright Security Agreement, dated as of January 31, 2011, and that certain Third Amended and Restated Patent, Trademark and Copyright Security Agreement, dated as of June 22, 2012 (collectively, the "Patent and Trademark Security Agreements");

WHEREAS, pursuant to said Patent and Trademark Security Agreements, Devin International granted to the Administrative Agent, among other collateral, a continuing security interest in all of Devin International's present and future right, title, and interest in all trade names, trademark applications, and trademarks, including those listed on the attached Schedule A (the "Marks"), whether then owned or thereafter acquired by Devin International, including all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all renewals and extensions thereof, and the goodwill of the business to which any of the trademarks relate;

WHEREAS, said Patent and Trademark Security Agreements were recorded in the United States Patent & Trademark Office on August 11, 2008 at reel/frame 03832/0308, on February 7, 2011 at reel/frame 04470/0118, on January 13, 2012 at reel/frame 4698/0354, and on June 27, 2012, at reel/frame 4809/0424; and

WHEREAS, the Administrative Agent wishes to release its security interest in all of the foregoing solely as to Devin International.

NOW THEREFORE, the Administrative Agent hereby releases any security interest it may have in Devin International's present and future right, title, and interest in all trade names, trademark applications, and trademarks, including those listed on the attached Schedule A, whether now owned or hereafter acquired by Devin International, including all proceeds thereof

(such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all renewals and extensions thereof, and the goodwill of the business to which any of the trademarks relate, and retransfers and reassigns any and all right, title, and interest it may have in the foregoing without recourse to Devin International. This Partial Release does **not** release any security interest that was granted in said Patent and Trademark Security Agreements by a person or entity other than Devin International.
