## RELEASE OF SECURITY INTEREST

This **RELEASE OF SECURITY INTEREST** (this "**Release**"), dated as of June 10, 2014, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Administrative Agent for the Secured Parties (as defined in the Credit Agreement referred to below) (the "**Administrative Agent**"). Terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement or the below defined Security Agreement, as applicable.

Reference is made to (i) the Credit Agreement, dated as of April 8, 2014 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the "**Credit Agreement**"), among, among others, Jasper Merger Sub, Inc. and Nine West Jeanswear Group, Inc. (collectively, the "**Borrower**"), Jasper Parent LLC, the Lenders party thereto from time to time and Administrative Agent, (ii) each Secured Hedge Agreement, (iii) each Secured Bank Product Agreement, and (iv) each Secured Cash Management Agreement.

Whereas, the Lenders have agreed to make extensions of credit to the Borrower pursuant to the Credit Agreement;

Whereas, in connection with the Credit Agreement, and pursuant to a Trademark Security Agreement dated as of April 8, 2014 (the "**Security Agreement**"), the Grantors (as defined in the Security Agreement) granted a security interest in certain intellectual property owned by the Grantors, including the Trademarks identified on Schedule A to the Security Agreement;

Whereas the Trademarks identified in the Security Agreement erroneously included the Trademarks listed on Schedule A attached hereto which are the property of Rachel Roy IP Company LLC and in which no Grantor has any ownership interest (collectively, the "**Rachel Roy Trademarks**");

Whereas, the Security Agreement was recorded in the U.S. Patent and Trademark Office on April 14, 2014 at Reel 5259, Frame 468; and

Whereas, this Release is being executed to remedy the obvious error of including the Rachel Roy Trademarks on Schedule A to the Security Agreement.

**NOW THEREFORE**, the Administrative Agent hereby releases, without representation, recourse or warranty whatsoever, the security interest (if any) that the Administrative Agent may have in the Rachel Roy Trademarks listed on Schedule A attached hereto, whether granted pursuant to the Security Agreement or any other agreement or document delivered in connection with the Credit Agreement.


The Administrative Agent agrees, at the expense of the Borrower, to cooperate with the Borrower and to provide the Borrower with the information and additional authorization reasonably required to effect and record the release of the Administrative Agent's security interests (if any) in such Rachel Roy Trademarks listed on Schedule A attached hereto. All of the Administrative Agent's rights under the Credit Agreement and Security Agreement in other intellectual property owned by the Borrower and each other Grantor shall remain in full force and effect.

By its execution hereof, the Administrative Agent and each of the Grantors acknowledges and agrees that the Rachel Roy Trademarks shall be deemed deleted from Schedule A to the Security Agreement and from Schedule 8(a) to the Perfection Certificate with the same effect as if they were never included thereon.
