## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “**Release**”) is made as of June 25, 2014 by MADISON CAPITAL FUNDING LLC, as Agent for the Lenders (the “**Agent**”) made in favor of THE RITEDOSE CORPORATION, a South Carolina corporation (“**Grantor**”).

WITNESSETH:

WHEREAS, Grantor entered into that certain Trademark Security Agreement, dated as of November 12, 2010 (the “**Agreement**”) in favor of Agent (all capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Agreement), pursuant to which Grantor granted a security interest to Agent in the Trademark Collateral, including the trademarks set forth on Schedule 1 hereto;

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on November 12, 2010, at Reel 4413, Frame 0747;

WHEREAS, Grantor has requested that Agent release its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral and assign the same to Grantor; and

WHEREAS, Agent has agreed to release the entirety of its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby terminates the Agreement and releases its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral, including the following:

(a) Each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark; and

(b) All products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of each such Trademark, or (b) injury to the goodwill associated with each such Trademark.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent’s right, title and interest (if any) in and to the Trademark Collateral and authorizes this Release to be recorded with the United States Patent and Trademark Office.


This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of Illinois.
