ACKNOWLEDGMENT OF SECURITY INTEREST IN TRADEMARKS

June 26, 2014

WHEREAS, WASHINGTON PENN PLASTIC CO., INC., a Pennsylvania corporation, UNIFORM COLOR COMPANY, a Michigan corporation and SOUTHERN POLYMER, INC., a Georgia corporation (each a "Grantor" and collectively, the "Grantors"), have adopted, used and are using (except as described on Schedule 1), and hold all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule 1, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, the Grantors have entered into a Pledge and Security Agreement, dated as of the date hereof (by and among the Grantors, the other loan parties party thereto, and the Agent (as defined below), as amended, restated, supplemented or otherwise modified from time to time in accordance with its terms, the "Security Agreement"), in favor of CITIZENS BANK OF PENNSYLVANIA, as administrative agent for certain lenders (the "Agent");

WHEREAS, pursuant to the Security Agreement, each Grantor has granted to the Agent for the benefit of certain lenders a continuing security interest in all right, title and interest of such Grantor in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor does hereby grant to the Agent for the benefit of certain lenders a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


