**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of June 23, 2014 (this "Release"), is made by JPMORGAN CHASE BANK, N.A., as Administrative Agent (in such capacity, "Agent") under the Pledge and Security Agreement described below, in favor of TROON GOLF, L.L.C., a Delaware limited liability company (the "Debtor") as follows:

**WITNESSETH**

WHEREAS, pursuant to the Amended and Restated Pledge and Security Agreement dated January 25, 2012, between Agent and Debtor, (the "Pledge and Security Agreement") which amended, restated and replaced in its entirety the Pledge and Security Agreement dated July 25, 2005, between Agent and Debtor, recorded with the United States Patent and Trademark Office on August 15, 2005, at Reel/Frame No. 3141/0001, the Debtor granted Agent a security interest on certain collateral pledged by Debtor described therein, including without limitation the United States trademark registrations set forth in **Schedule A** attached hereto and the License Agreements referenced in Part D of Exhibit 'B' to the Pledge and Security Agreement (collectively, the "Trademark Collateral");

WHEREAS, the Pledge and Security Agreement was made pursuant to the Amended and Restated Credit Agreement dated as of January 25, 2012 (as it may be amended or modified from time to time, the "Credit Agreement");

WHEREAS, the Debtor has paid all of its outstanding indebtedness to the lenders party to the Credit Agreement (collectively with the Agent, and their successors and assigns, the "Lenders"); and

WHEREAS, the Debtor has requested that the Agent release its security interest in and lien on the Trademark Collateral.


NOW, THEREFORE, Agent, at the Debtor's sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and all right, title and interest of the Agent or the other Lenders in the Trademark Collateral shall hereby terminate, cease and become void.

Agent agrees to provide the Debtor with any information and additional authorization and documentation necessary to effect the release of Agent's security interest in the released Trademark Collateral at the Debtor's sole cost and expense.
