## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made in favor of PSA-MHF Acquisition, LLC, a Delaware limited liability company ("PSA-MHF"), and Production Services Associates, LLC, a Delaware limited liability company ("PSA") PSH-MHF and PSA are referred to herein, collectively, as "Grantors" and, individually, as a "Grantor") by Madison Capital Funding LLC, in its capacity as agent (in such capacity, the "Agent") for certain financial institutions (the "Lenders").

WHEREAS, Agent wishes to terminate, cancel and release all liens and security interests it has in and on the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates, cancels and releases all liens and security interests it has in and on the Trademarks; all income, royalties, damages and payments now and hereafter due and/or payable related thereto, including, including without limitation, damages and payments for past or future infringements thereof; the right to sue for past, present and future infringements thereof; and any goodwill associated thereto.

Agent shall take all further actions, and provide to each Grantor all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor to more fully and effectively effectuate the purposes of this Release.
