RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, BRAVO SPORTS, a California corporation, BRAVO SPORTS HOLDING CORPORATION, a Delaware corporation, VARIFLEX, INC., a Delaware corporation, and BRAVO EUROPE, INC., a California corporation (each individually a "Grantor", and individually and collectively, jointly and severally, the "Grantors"), granted a security interest in and to all of the Grantors' right, title and interest in and to certain trademarks and applications for trademarks to JPMorgan Chase Bank, N.A., as administrative agent (the "Administrative Agent") as set forth in that certain Trademark Security Agreement, dated as of July 19, 2011, by the Grantors in favor of the Administrative Agent (the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office on August 18, 2011, at Reel/Frame Number 004611/0289;


WHEREAS, the Administrative Agent has agreed to release certain collateral in connection with a sale of certain assets owned by the Grantors.

1. releases any and all security interests, right, title and interest of the Administrative Agent granted pursuant to the Trademark Security Agreement solely in and to the collateral listed on Schedule I hereto (the "Released Collateral") without recourse or representation or warranty, express or implied, of any kind or nature whatsoever;
2. retains all of its liens and security interests in all collateral covered by the Trademark Security Agreement, other than the Released Collateral; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
