**TRADEMARK SECURITY AGREEMENT SUPPLEMENT**

**(Trademark Registrations, Trademark Applications and Exclusive Trademark Licenses)**

This TRADEMARK SECURITY AGREEMENT SUPPLEMENT (this “**Supplement**”), dated July 8, 2014, is made by Educational Management LLC (the “**Lien Grantor**”) in favor of U.S. Bank National Association, as Collateral Agent for the Secured Parties (in such capacity, the “**Grantee**”).

WHEREAS, the Lien Grantor owns, or in the case of licenses is a party to, the Additional Trademark Collateral (as defined below); and

WHEREAS, the Lien Grantor, Education Management Holdings LLC (“**Holdings**”), Certain Subsidiaries of Holdings, as Guarantors, the Lenders party thereto from time to time, U.S. Bank National Association (as successor administrative agent and collateral agent to BNP Paribas), as Administrative Agent and as Collateral Agent and the Lenders party thereto from time to time are parties to that certain Second Amended and Restated Credit and Guaranty Agreement, dated as of February 13, 2007, as amended and restated as of December 7, 2010 (as further amended, restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”); and

WHEREAS, (i) the Lien Grantor, Holdings, the other Grantors party thereto and the Grantee (in such capacity, as successor to BNP Paribas) are party to that certain Pledge and Security Agreement, dated as of June 1, 2006 (as amended and/or supplemented from time to time, the “**Security Agreement**”) and (ii) the Lien Grantor and the Grantee (in such capacity, as successor to BNP Paribas) are party to certain other Security Documents, including that certain Trademark Security Agreement, dated as of June 1, 2006 (as amended and/or supplemented from time to time, the “**Trademark Security Agreement**”); and

WHEREAS, under the terms of the Security Agreement, the Lien Grantor has granted to the Grantee for the benefit of the Secured Parties a continuing security interest in certain intellectual property of the Lien Grantor and has agreed to execute this Supplement for recording with the United States Patent and Trademark Office; and

WHEREAS, the Lien Grantor has duly authorized the execution, delivery and performance of this Supplement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, in order to induce the Lenders to make Loans and other financial accommodations to the Lien Grantor pursuant to the Credit Agreement, the Lien Grantor agrees, for the benefit of the Secured Parties, as follows:

1. Grant of Security Interest. For the benefit of the Secured Parties to secure payment, performance and observance of the Secured Obligations, the Lien Grantor pledges and grants to the Grantee, a continuing security interest in, and a right of set-off against, and agrees to assign, transfer and convey, upon demand made upon the occurrence and during the continuance of an Event of Default without requiring further action by either party and to be effective upon such

demand, all of the Lien Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "**Additional Trademark Collateral**"), whether now owned or existing or hereafter acquired or arising:

(i) each Trademark owned by the Lien Grantor, including, without limitation each Trademark registration and application referred to in Schedule 1 hereto, but in all cases excluding any intent-to-use (ITU) United States trademark application for which an amendment to allege use or statement of use has not been filed under 15 U.S.C. § 1051(c) or 15 U.S.C. § 1051(d), respectively, or, if filed, has not been deemed in conformance with 15 U.S.C. § 1051(a), or examined and accepted, respectively, by the United States Patent and Trademark Office, in each case, only to the extent the grant of security interest in such intent-to-use Trademark is in violation of 15 U.S.C. § 1060 and only unless and until a "Statement of Use" or "Amendment to Allege Use" is filed, has been deemed in conformance with 15 U.S.C. §1051(a) or examined and accepted, respectively, by the United States Patent and Trademark Office at which point such Trademarks shall automatically be subject to the security interest granted herein and be deemed to be included as Additional Trademark Collateral; and

(ii) each exclusive Trademark License to which the Lien Grantor is a party, including, without limitation, each exclusive Trademark License identified in Schedule 1 hereto.

The Lien Grantor irrevocably constitutes and appoints the Grantee and any officer or agent thereof, with full power of substitution, as its true and lawful attorney-in-fact with full power and authority in the name of the Lien Grantor or in the Grantee's name, from time to time, in the Grantee's discretion, so long as any Event of Default shall have occurred and be continuing, to take with respect to the Additional Trademark Collateral any and all appropriate action which the Lien Grantor might take with respect to the Additional Trademark Collateral and to execute any and all documents and instruments which may be necessary or desirable to carry out the terms of this Supplement and to accomplish the purposes hereof.

Except to the extent expressly permitted in the Security Agreement or the Credit Agreement, the Lien Grantor agrees not to sell, license, exchange, assign or otherwise transfer or dispose of, or grant any rights with respect to, or mortgage or otherwise encumber, any of the Additional Trademark Collateral.

2. Purpose. This Supplement has been executed and delivered by the Lien Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Grantee in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The Security Agreement (and all rights and remedies of the Lenders thereunder) shall remain in full force and effect in accordance with its terms.

3. Acknowledgement. The foregoing security interest is granted in conjunction with the security interests granted by the Lien Grantor to the Grantee pursuant to the Security Agreement. The Lien Grantor acknowledges and affirms that the rights and remedies of the Grantee with respect to the security interest in the Additional Trademark Collateral granted hereby are more

fully set forth in the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the terms of this Supplement and the terms of the Security Agreement, the terms of the Security Agreement shall govern.

4. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Supplement, including its preamble and recitals, have the meanings provided by reference in the Security Agreement.

5. Counterparts. This Supplement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
