## RELEASE OF TRADEMARK AND PATENT SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK AND PATENT SECURITY AGREEMENT (this “**Release**”) is made effective as of July 3, 2014 (the “**Effective Date**”) , by PNC BANK, NATIONAL ASSOCIATION (“**Grantee**”), in favor of GREAT WESTERN CO., LLC, a Delaware limited liability company (“**Grantor A**”), TEC CHEM CO., LLC, a Delaware limited liability company (“**Grantor B**”), and MOVIE FOODS CO., LLC, a now dissolved Delaware limited liability company (“**Grantor C**”; Grantor A, Grantor B and Grantor C are hereinafter collectively referred to as “**Grantors**”).

WHEREAS, pursuant to a Trademark and Patent Security Agreement dated as of January 2, 2009 (the “**Security Agreement**”), from Grantors to Grantee, Grantors granted to Grantee a security interest in, and a lien upon, all of Grantors’ respective right, title and interest in and to (i) each trademark and patent listed on Schedule 1 annexed hereto (such trademarks and patents, the “**Trademarks**” and “**Patents**”), together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, and (ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantors against third parties for past, present or future (a) infringement or dilution of any Trademark or Patent or (b) injury to the goodwill associated with any Trademark (all of the foregoing under clauses (i) and (ii) is, collectively, the “**IP Collateral**”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on February 2, 2009, at Reel 3928, Frame 0073; and


WHEREAS, Grantee desires to terminate the Security Agreement and release its security interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Grantee hereby unconditionally and expressly releases and terminates, and extinguishes any and all of its right, title and interest in and to, and any and all liens and security interests it may have upon, all of the IP Collateral.

This Release shall be binding upon Grantee’s legal representatives, assigns and successors.

IN WITNESS WHEREOF, Grantee has caused this Release to be executed by its duly authorized representative as of the Effective Date.






