TERMINATION OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

October 5, 2012

WHEREAS, UNITED SITE SERVICES, INC., for itself and as successor in interest to each of 1-800 Toilets, Inc. and Handy House, Inc. (in such capacities, the "Grantor") had granted to CRÉDIT SUISSE AG, CAYMAN ISLANDS BRANCH (formerly known as Credit Suisse, Cayman Islands Branch) in its capacity as collateral agent (in such capacity, the "Agent") for the Secured Parties referred to in the Agreements (as defined below), a continuing security interest (the "Security Interest") in (a) (i) all trademarks, service marks, trade names, corporate names, company names, business names, trade dress, trade styles, logos, or other indicia of origin or source identification, trademark and service mark registrations, and applications for trademark or service mark registrations and any new renewals thereof, including, without limitation, each registration and application identified in Schedule 1, (ii) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (iii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iv) all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each of the above (collectively, the "Trademarks"); (b) (i) all licenses or agreements, whether written or oral, providing for the grant by or to the Grantor of any right to use any Trademark, (ii) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations of any of the foregoing, (iii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iv) all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto; and (c) any and all proceeds of the foregoing (all of the foregoing, collectively, the "Collateral"), pursuant to, among other things, (a) a certain Intellectual Property Security Agreement dated as of June 29, 2006 (the "2006 Agreement"), which was filed at the United States Patent and Trademark Office on July 10, 2006 and recorded on Reel 3344, Frame 0393, and (b) a certain Amended and Restated Intellectual Property Security Agreement dated as of December 15, 2009 (the "2009 Agreement"), and together with the 2006 Agreement, individually, an "Agreement", and collectively, the "Agreements"; capitalized terms used herein but not otherwise defined herein shall have the meanings assigned to such terms in the Agreements), which was filed at the United States Patent and Trademark Office on December 31, 2009 and recorded on Reel 4122, Frame 0894; and

WHEREAS, the Grantor has made payment in full of the indebtedness secured by the Security Interest in exchange for the termination of the Security Interest.

NOW, THEREFORE, the Agent releases and discharges its security interest in, and reassigns to the Grantor, any and all interest in the Collateral, including, without limitation, the


Trademarks set forth on Schedule 1 attached hereto, and the goodwill of the businesses with which the Trademarks are associated. The Agent agrees that, upon request of the Grantor or any successor-in-interest or assignee thereof, and at the Grantor's sole cost and expense, the Agent will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantor, or any successor-in-interest or assignee thereof, to effectuate the release of interests contemplated herein.



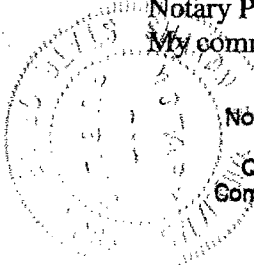
