**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE, dated as of August 5, 2014, is made by JPMORGAN CHASE BANK, N.A. (as successor to Bear Stearns Corporate Lending Inc.), as Administrative Agent (in such capacity, and together with its successors in such capacity, the "Administrative Agent") pursuant to the Second Lien Credit Agreement, dated as of August 22, 2007, by and between Hunter Defense Technologies, Inc., the Administrative Agent, and the other parties thereto (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Second Lien Guarantee and Collateral Agreement, dated as of August 22, 2007, by and between Hunter Defense Technologies, Inc., the Administrative Agent, and the other parties thereto (as amended, restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Guarantee and Collateral Agreement.

**W I T N E S S E T H**

WHEREAS, Hunter Defense Technologies, Inc., HDT Expeditionary Systems, Inc. (formerly known as Base-X, Inc.), HDT Tactical Systems, Inc. (formerly known as Hunter Manufacturing Company), and HDT Robotics, Inc. (collectively, the "Grantors") are parties to the Guarantee and Collateral Agreement;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantors executed the (i) Second Lien Trademark Security Agreement dated August 22, 2007 and recorded with the U.S. Patent and Trademark Office ("USPTO") on August 23, 2007 at Reel/Frame Nos. 3607/0873 and 3607/0888 (the "August 2007 Trademark Security Agreement"), (ii) After-Acquired Second Lien Trademark Security Agreement (First Supplemental Filing) dated May 13, 2010 and recorded with the USPTO on May 18, 2010 at Reel/Frame Nos. 4208/0374 and 4208/0387 (the "May 2010 Trademark Security Agreement"), (iii) Second Lien Trademark Security Agreement dated March 11, 2011 and recorded with the USPTO on March 11, 2011 at Reel/Frame No. 4497/0138 (the "March 2011 Trademark Security Agreement"), and (iv) Second Lien Trademark Security Agreement dated November 7, 2013 and recorded with the USPTO on November 11, 2013 at Reel/Frame Nos. 5151/0639 and 5151/0648 (the "November 2013 Trademark Security Agreement") (collectively, the "Trademark Security Agreements"), pursuant to which the Grantors granted to the Administrative Agent for the ratable benefit of the Secured Parties a security interest in all of the Trademark Collateral (as defined in the Trademark Security Agreements);

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantors have requested that the Administrative Agent release its security interest in all of the Trademark Collateral.

NOW, THEREFORE, the Administrative Agent hereby TERMINATES, without recourse, representation or warranty the Trademark Security Agreements, and RELEASES, without recourse, representation or warranty its security interest in all of the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I, attached hereto and incorporated herein by reference.
