RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of July 30, 2014, is made by TD Bank, N.A. ("Secured Party").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 26, 2011, by and between ShelterLogic Corp. ("Grantor") and Secured Party, Grantor granted to Secured Party a security interest in certain registered trademarks of Grantor, which registered trademarks are more fully identified on Schedule A annexed hereto and made a part hereof (the "Released Trademarks").



NOW THEREFORE, Secured Party hereby absolutely, unconditionally, and irrevocably releases, terminates and discharges Secured Party's security interest in, lien on, and conditional assignment of the Released Trademarks and Secured Party hereby reassigns to Grantor any and all such right, title and interest (if any) that the Secured Party may have in the Released Trademarks. Secured Party hereby authorizes the recordation of this Release with the USPTO. Secured Party agrees to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required to effect the release of the Secured Party's security interest in the Released Trademarks and the termination of the Trademark Filings.
