**TERMINATION AND RELEASE OF IP
SECURITY AGREEMENT**

This Termination and Release of IP Security Agreement (this "Release") is conveyed as of July 31, 2014, by PNC BANK, NATIONAL ASSOCIATION, as Agent for itself and other Lenders under the Security Agreement referred to below (in such capacity, the "Agent"), in favor of ULTRAVOLT, INC., a New York corporation (the "Debtor").

WHEREAS, reference is made to that certain Revolving Credit, Guaranty and Security Agreement, dated as of February 8, 2008 (as amended, amended and restated, supplemented or otherwise modified to the date hereof, the "Security Agreement"), by and among the Debtor, the other obligors party thereto from time to time and the Agent.

WHEREAS, the Agent and the Debtor executed an Intellectual Property Security Agreement, dated February 8, 2008, which was recorded with the United States Patent and Trademark Office (the "USPTO") on February 26, 2008, at Reel 020555 Frame 0281, under which the Debtor granted to the Agent a security interest in its interest in the patents and patent applications listed on the attached Schedule A (the "Patents").


WHEREAS, the Agent and the Debtor executed an Intellectual Property Security Agreement, dated February 8, 2008, which was recorded with the USPTO on February 26, 2008, at Reel 003726 Frame 0454, under which the Debtor granted to the Agent a security interest in its interest in the trademark registrations and the trademark applications listed on the attached Schedule B (collectively, the "Trademarks") and the goodwill associated therewith.

WHEREAS, the Agent wishes to terminate the Security Agreement and release, retransfer and reassign to each Debtor, without representation or warranty, all of the Agent's right, title and interest in and to the Trademarks and the goodwill associated therewith, and the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Agent hereby terminates the Security Agreement and releases, retransfers and reassigns to each Debtor, without representations or warranty, all of the Agent's right, title and interest in and to the Trademarks and the goodwill associated therewith, and the Patents.
