WITNESSETH:



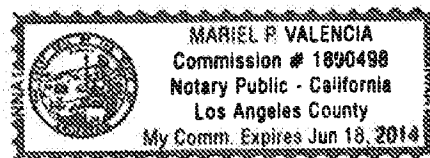
