**TERMINATION AND RELEASE OF  
SECURITY INTERESTS IN PATENTS AND TRADEMARKS**

This Termination and Release of Security Interests in Patents and Trademarks (the "Termination and Release") is granted as of August 15, 2014, from PNC Bank, National Association as administrative agent (the "Administrative Agent") for the lenders and other financial institutions that are parties to a Credit Agreement (as amended, modified, supplemented or restated from time to time, the "Credit Agreement"), to KOPPERS INC., a Pennsylvania corporation and the Guarantors party thereto (hereinafter collectively referred to as the "Koppers Companies").

**WITNESSETH:**

WHEREAS, pursuant to the Patent, Trademark and Copyright Security Agreement dated May 12, 2003 (the "Security Agreement"), made by the Koppers Companies in favor of the Administrative Agent, the Koppers Companies granted security interests (the "Security Interests") to the Administrative Agent in those certain Patents and Trademarks listed on Schedule A attached hereto and made a part hereof; and

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on May 15, 2003, at Reel 2736, Frame 0813; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interests in the Patents and Trademarks owned by the Koppers Companies;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

1. Release of Security Interests: The Administrative Agent hereby terminates, releases and discharges its Security Interests in the Patents and Trademarks, and any right, title or interest of the Administrative Agent in such Patent and Trademarks shall hereby immediately cease and become void.



Authorization: The Administrative Agent hereby authorizes and directs the Commissioner of the United States Patent and Trademark Office, as well as the intellectual property offices of any other jurisdictions where the Patents or Trademarks are registered, to release the above-referenced Security Interests.

3. Further Assurances: At the request and sole expense of the Koppers Companies, the Administrative Agent shall execute and deliver to the Koppers Companies any such additional documents as the Koppers Companies may reasonably request to evidence the termination and release of the Security Interests.
