Trademark Purchase and Domain Name Transfer Agreement

This Trademark Purchase and Domain Name Transfer Agreement ("**Agreement**"), dated as of January 2, 2014 (the "**Effective Date**"), is by and between UBM Canon LLC, a Delaware limited liability company with offices located at 2901 28th Street, Suite 100, Santa Monica, CA 90405 ("**Seller**"), and OUTCOMES, LLC with offices located at 23 Billingsley Drive, Livingston, NJ 07039 ADDRESS ("**Buyer**").

WHEREAS, Seller, among other things, is engaged in the business of owning and operating the website Pharmalive (the "**Business**");

WHEREAS, Seller is the owner of all right, title and interest in the domain names listed on Exhibit A to this Agreement (the "**Domain Names**") and is the registrant of the Domain Names with CSC;

WHEREAS, Seller is the owner of all right, title and interest in the trademarks related to the Business listed on Exhibit B to this Agreement (the "**Trademarks**");

WHEREAS, Buyer wishes to acquire all right, title and interest in the Domain Names and the Trademarks (the "**Purchased Assets**"); and

WHEREAS, the parties have agreed to Seller's sale of the Purchased Assets to Buyer on the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants, terms and conditions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Purchase of Purchased Assets. In consideration of the Purchase Price (as defined below), Seller hereby irrevocably sells, assigns, transfers and conveys to Buyer:

(a) all right, title and interest in and to the Domain Names, including the current registration thereof with CSC;

(b) any other rights (including, but not limited to, trademark rights in any jurisdiction) Seller may have in the Domain Names, including any goodwill associated therewith; and

(c) all right, title and interest in and to the Trademarks, including any goodwill associated therewith.

2. Purchase Price.

(a) In consideration of Seller's sale and transfer of the Purchased Assets and Seller's other agreements hereunder, Buyer shall pay to Seller [REDACTED] (the "**Purchase Price**") in accordance herewith.

(b) Buyer shall pay the Purchase Price in cash within ONE (1) business days following the parties' full execution of this Agreement.

3. Transfer of Trademarks and Domain Names.

(a) Within one business day following receipt of the Purchase Price, Seller shall execute all documents, papers, forms and authorizations, and take such other actions as are necessary to effectuate the transfer of ownership and control of the Trademarks and Domain Names to Buyer, and enable Buyer to register the Domain Names in the name of Buyer with the following domain name registrar: GoDaddy.com.
