RELEASE OF SECURITY AGREEMENT - TRADEMARKS

WHEREAS, pursuant to that certain Trademark Security Agreement, dated June 26, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "TSA"; capitalized terms used herein but not otherwise defined in this release shall have the meanings ascribed thereto in the TSA), recorded in the United States Patent and Trademark Office at Reel 4809, Frame 0690 on June 27, 2012 and in the Canadian Intellectual Property Office on July 27, 2012, Line-X Intermediate Holdings LLC, a Delaware limited liability company (the "Parent"), Line-X LLC, a Delaware limited liability company ("Line-X"), Line-X Franchising LLC, a California limited liability company ("Line-X Franchising"), and Ground Effects LLC, a Delaware limited liability company ("Ground Effects" and together with the Parent, Line-X and Line-X Franchising, each a "Releasee" and collectively, the "Releasees"), granted to PNC Bank, National Association, in its capacity as U.S. collateral agent for itself and the other Secured Parties (together with its successors and assigns in such capacity, "Releasor"), a continuing security interest in all of such Releasees' right, title and interest in and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), including without limitation the Trademarks listed on Schedule I, and

WHEREAS, Releasor desires to provide a document suitable for recording in the United States Patent and Trademark Office to record the release, relinquishment, termination and discharge of Releasor's security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby releases, relinquishes, terminates and discharges its security interest in the Collateral. Releasor hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Releasees' expense, as may be reasonably necessary to effect the release of the security interest in the Collateral contemplated hereby.
