TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of September 3, 2014 by GENERAL ELECTRIC CAPITAL CORPORATION, as administrative agent (in such capacity, “**Agent**”) for certain financial institutions, in favor of INSIGHT PHARMACEUTICALS LLC (“**Grantor**”).

WITNESSETH:

WHEREAS, Agent and Grantor, were parties to that certain Second Lien Trademark Security Agreement dated as of August 26, 2011 (the “**Assignment**”), pursuant to which Grantor granted a security interest to Agent in the Trademark Collateral (as defined therein) (the “**Trademark Collateral**”) as security for certain obligations owing by Grantor to Agent, including the registered trademarks set forth on Exhibit A attached hereto.

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on August 31, 2011, at Reel 004614, Frame 0720; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Assignment), including the registered trademarks described on Exhibit A attached hereto.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral, and agrees that it shall execute all other documents and do all other acts reasonably requested to relinquish and effect the release of such rights to Grantor.
