**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “*Release*”) is made as of September 17, 2014 (the “*Effective Date*”), by Wilmington Trust, National Association, as collateral agent on behalf of the Secured Parties (in such capacity, the “*Agent*”), in favor of Tri-Ed Distribution Inc. and Communications Cables, LLC (the “*Grantors*”).

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement among the Grantors and the Agent, dated as of July 1, 2013 (the “*Trademark Security Agreement*”), the Grantors pledged and granted to the Agent a lien on and security interest in all of its right, title and interest in and to certain collateral identified in said Trademark Security Agreement, including, without limitation, the trademark registrations and applications set forth on Schedule I hereto, along with the goodwill associated therewith (collectively, the “*Released Trademarks*”);

**WHEREAS**, the Trademark Security Agreement was recorded with the Assignment Division of the U.S. Patent & Trademark Office on July 3, 2013, at Reel 5063 and Frame 0206;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the Released Trademarks arising under the Trademark Security Agreement.



The Agent shall take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, and at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
