**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 30, 2014 ("Release"), is made by PNC Bank, National Association, as Agent ("Agent") in favor of Chattanooga Shooting Supplies, Inc., a Tennessee corporation ("Grantor").

**WHEREAS**, pursuant to that certain Revolving Credit and Security Agreement dated as of June 29, 2007 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Loan Agreement") by and among Grantor, Lenders and Agent, Grantor granted to Agent, for its benefit and for the ratable benefit of Lenders ("Secured Parties"), a continuing security interest in and to and Lien on all of its Collateral, including trademarks, trademark applications, and goodwill associated with the foregoing ("Trademark Collateral");

**WHEREAS**, pursuant to the Loan Agreement, Grantor executed and delivered to Agent, for the ratable benefit of the Secured Parties, the Notice of Grant of Security Interest in Trademarks dated as of June 29, 2007 ("Notice"); and

**WHEREAS**, the Notice was recorded at the United States Patent and Trademark Office ("USPTO") on July 17, 2007 at Reel 3581 Frame 0705.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, on behalf of the Secured Parties, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Loan Agreement or Notice.

**SECTION 2. Termination and Release.** Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to Grantor's right, title, and interest in, to, and under all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Tennessee.

IN WITNESS WHEREOF, the Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
