**TRADEMARK ASSIGNMENT**

**THIS TRADEMARK ASSIGNMENT** (this "*Assignment*") is made and entered into by and between Mansfield Oil Company of Gainesville, Inc., a Georgia corporation ("*Assignor*") and Empire Petroleum Partners, LLC, a Delaware limited liability company ("*Assignee*").

**RECITALS**

**R.1** Assignor is the sole and exclusive owner of the United States trademark SOLO and the goodwill of the business symbolized thereby, which has been registered with the United States Patent and Trademark Office as Reg. No. 2,696,136, which has been maintained on August 19, 2008 and renewed on July 25, 2012, and is incontestable and currently valid (the "*Mark*").

**R.2** The parties hereto desire by means of this Assignment to assign, convey and transfer all right, title and interest in the Mark to Assignee.

**NOW THEREFORE**, in consideration of the foregoing Recitals, which are incorporated herein by reference and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said Assignor does hereby sell, assign, convey, and transfer unto said Assignee all of Assignor's right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, the same to be held and enjoyed by Assignee for its own use, and for the term or terms for which said Mark has been registered as fully and entirely as the same would have been held and enjoyed by Assignor, including all rights to injunctive relief, damages or profits, due or accrued, arising out of past infringement of the Mark or injury to its goodwill, and the right to sue for and recover the same in its, the Assignee's, own name.
