INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (this "Agreement") is entered into as of October 7, 2014 by and among SILICON VALLEY BANK, a California corporation, with a loan production office located at 275 Grove Street, Suite 2-200, Newton, Massachusetts 02466 ("Bank"), and each of INTERSECTIONS INC., a Delaware corporation, with its principal place of business located at 3901 Stonecroft Blvd., Chantilly, Virginia 20151, I4C INNOVATIONS INC., a Delaware corporation, with its principal place of business located at 3800 Concorde Parkway, Suite 400, Chantilly, Virginia 20151, and INTERSECTIONS INSURANCE SERVICES INC., an Illinois corporation, with its principal place of business located at 35 West University Drive, Arlington Heights, Illinois 60004 (each, a "Grantor", and, collectively, the "Grantors").

RECITALS

A. Bank has agreed to make certain advances of money and to extend certain financial accommodations (the "Loans") to Intersections Inc. (the "Borrower") in the amounts and manner set forth in that certain Loan and Security Agreement by and between Bank and the Borrower, dated as of the date hereof (as the same may be amended, modified or supplemented from time to time, the "Loan Agreement"; capitalized terms used herein are used as defined in the Loan Agreement). Bank is willing to make the Loans to the Borrower, but only upon the condition, among others, that each Grantor shall grant to Bank a security interest in that portion of its own Intellectual Property constituting Collateral (the "Intellectual Property Collateral") to secure the obligations of such Grantor to Bank.

B. Pursuant to the terms of the Loan Agreement and the other Loan Documents, each Grantor has granted to Bank a security interest in, to and under all of the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of each Grantor's obligations to Bank, Grantor hereby represents, warrants, covenants and agrees as follows:

AGREEMENT

1. Grant of Security Interest. To secure such Grantor's obligations to Bank, each Grantor grants and pledges to Bank a security interest in all of such Grantor's right, title and interest in, to and under its own Intellectual Property Collateral, including, without limitation, the following:

(a) Any and all Copyrights, including, without limitation, those set forth on Exhibit A attached hereto;

(b) Any and all Patents, including, without limitation, those set forth on Exhibit B attached hereto;

(c) Any and all Trademarks, including, without limitation, those set forth on Exhibit C attached hereto; and

(d) All proceeds and products of the foregoing.

2. Recordation. Each Grantor authorizes, as applicable and with respect to the applicable Intellectual Property Collateral, the Commissioner for Patents, the Commissioner for Trademarks and the Register of Copyrights and any other government officials to record and register this Agreement upon request by Bank.
3. Loan Documents. This Agreement has been entered into pursuant to and in conjunction with the Loan Agreement, which is hereby incorporated by reference. The provisions of the Loan Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of Bank with respect to the Intellectual Property Collateral are as provided by the Loan Agreement and the other Loan Documents, and nothing in this Agreement shall be deemed to limit such rights and remedies.
4. Execution in Counterparts. This Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Agreement by facsimile or in electronic (i.e., "pdf" or "tif" format) shall be effective as delivery of a manually executed counterpart of this Agreement.
5. Successors and Assigns. This Agreement will be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns.
6. Governing Law. This Agreement and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Agreement and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
