**RELEASE OF SECURITY INTEREST IN

This RELEASE, dated as of October 17, 2014, is made by The Bank of New York Mellon Trust Company, N.A., as trustee under the Indenture (in such capacity, the "Trustee") pursuant to the Indenture, dated as of October 24, 2008 (as amended, supplemented or otherwise modified from time to time, the "Indenture") and the Security Agreement, dated as of October 24, 2008 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), in each case, among the Grantors (as defined below), the Trustee and the other parties party thereto. Capitalized terms not otherwise defined herein have the meaning assigned to them in the Security Agreement.

W I T N E S S E T H

WHEREAS, GACCF, LLC, a Delaware limited liability company, PTF, LLC, a Delaware limited liability company, PMF, LLC, a Delaware limited liability company, TCBY Systems, LLC, a Delaware limited liability company, The Mrs. Fields' Brand, Inc., a Delaware corporation, and Mrs. Fields' Original Cookies, Inc., a Delaware corporation (collectively, the "Grantors") are parties to the Security Agreement;


WHEREAS, pursuant to the Security Agreement, the Grantors executed the Trademark Security Agreement dated October 24, 2008, among the Grantors and the Trustee (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on October 30, 2008 at Reel/Frame No. 3880/0161, pursuant to which each Grantor granted to the Trustee, on behalf of and for the benefit of itself and the Holders, and to secure the prompt and complete payment and performance of all Secured Obligations, a security interest in all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, pursuant to the Security Agreement, the Grantors have requested that the Trustee release its security interest in all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Trustee, without recourse, representation or warranty hereby (i) TERMINATES and RELEASES, with respect to each Grantor, all of its right, title and interest in and to the security interest in all of such Grantor's Trademark Collateral, including the trademark registrations and applications set forth in Schedule A, (ii) re-assigns to such Grantor any and all right, title or interest in may have in such Trademark Collateral, and (ii) agrees, confirms and acknowledges that the Trademark Security Agreement is hereby terminated. In addition, the Trustee agrees, at the Grantors' sole cost and expense, to provide the Grantors with further information and additional authorization reasonably necessary to evidence such release as may be reasonably requested by the Grantors.
