**RELEASE OF TRADEMARK SECURITY INTEREST**

WHEREAS, pursuant to a certain Trademark Security Agreement, dated as of July 31, 2009 (the "Trademark Security Agreement"), NFA CORP., a Massachusetts Corporation (the "Debtor"), granted to BANK OF AMERICA, N.A. (the "Lender"), a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement) including those trademarks set forth in Schedule A, attached hereto;

The Lender hereby authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this release of security interest in trademarks.
