PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "**Release**") is made as of November 3, 2014, by BANK OF AMERICA, N.A., as Administrative Agent for the Secured Parties (as defined in the Credit Agreement referred to below) (the "**Administrative Agent**"), in favor of Chemtura Corporation, a Delaware corporation (the "**Company**") and each of the Persons listed on Schedule A attached hereto (together with the Company, collectively, the "**Grantors**").

WHEREAS, the Company and the Subsidiary Borrowers (together with the Company, the "**Borrowers**") entered into a Senior Secured Revolving Facility Credit Agreement dated as of November 10, 2010, as amended and restated as of December 4, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**") with the Administrative Agent and the Lender Parties and the other agents party thereto. Terms defined in the Credit Agreement and not otherwise defined herein are used herein as defined in the Credit Agreement;

WHEREAS, pursuant to the Credit Agreement, the Grantors party thereto executed and delivered that certain Security Agreement dated as of November 10, 2010, amended and restated as of December 4, 2013, made by the Grantors party thereto to the Administrative Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Security Agreement**");

WHEREAS, pursuant to the Security Agreement, the Grantors party thereto executed and delivered (i) that certain Amended and Restated Second Lien Intellectual Property Security Agreement dated as of January 31, 2014 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**IP Security Agreement**"), pursuant to which the Grantors granted to the Administrative Agent a security interest in all of the Grantors' right, title, and interest in and to certain intellectual property, including the Collateral (as defined in the IP Security Agreement) (such intellectual property, collectively, the "**Pledged IP Collateral**");

WHEREAS, the IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on July 18, 2014 at Reel 033360, Frame 0225; with the Trademark Division of the United States Patent and Trademark Office on July 18, 2014 at Reel 005325, Frame 0706; and

WHEREAS, the Grantors desire to transfer certain of their respective assets, including a portion of the Pledged IP Collateral, to certain third parties, and has requested that the Administrative Agent release its security interest in such Pledged IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

SECTION 1. Partial Release of Security Interest. The Administrative Agent, on behalf of itself and the other Secured Parties, hereby terminates and releases all of the Administrative Agent's security interest in all of the Grantors' right, title, and interest in and to the following portion of the Pledged IP Collateral (collectively, the "**Released IP Collateral**"):

- a. all patents and patent applications set forth in Schedule B hereto (the "**Patents**");

- b. all trademark and service mark registrations and applications set forth in Schedule C hereto, together, in each case, with the goodwill symbolized thereby (the “*Trademarks*”);
- c. all copyright registrations and applications set forth in Schedule D hereto (the “*Copyrights*”);
- d. all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, and all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;
- e. any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
- f. any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any of the foregoing, except for any and all proceeds received by the Grantors from the transfer of the Released IP Collateral in connection with which this Release is made.

The foregoing release of the Released IP Collateral shall be limited only to the Released IP Collateral, made by the Administrative Agent for the benefit of the Grantors as of the date hereof. The release of the Administrative Agent’s security interest in the Released IP Collateral shall not be construed to evidence or reflect the payment or satisfaction of any of the indebtedness or other obligations of the Company, GLCC or any of their affiliates (excluding the other Grantors) to the Administrative Agent or any of the Secured Parties. The foregoing release of the Released IP Collateral is made without any representation or warranty by the Administrative Agent as to the Released IP Collateral.

SECTION 2. Recordation. The Administrative Agent hereby authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer or relevant governmental authority record this Release. The Administrative Agent further agrees to execute and deliver to the Grantors any and all further documents and instruments, and do any and all further acts which a Grantor (or its agents or designees) reasonably requests (at such Grantor’s sole cost and expense) in order to more fully and effectively effectuate the purposes of this Release.

SECTION 3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
