**THIS ASSIGNMENT OF MARK** ("Assignment") is made as of October 31, 2014 by **MARLIN BROADCASTING, LLC**, a Delaware limited liability company ("Assignor") in favor of **EDUCATIONAL MEDIA FOUNDATION**, a California non-profit corporation ("Assignee") pursuant to the terms of that certain Asset Purchase Agreement dated as of July 23, 2014 (the "Purchase Agreement") among Assignor, Marlin Broadcasting of Hartford, LLC, Beethoven.Com, LLC and Marlin Tower, LLC (collectively "Sellers") and Assignee.

**WHEREAS**, pursuant to the Purchase Agreement, Assignee is acquiring the assets, properties, interests and rights of Sellers used in connection with the operation of radio broadcast stations WCCC(AM), Hartford, Connecticut (1290 kHz, FCC Facility Id. # 25073) and WCCC-FM, Hartford, Connecticut (106.9 MHz, FCC Facility Id. # 25072 (the "Stations").

**WHEREAS**, Assignor is a limited liability company organized under the laws of the state of Delaware and having its principal office at 1039 Asylum Avenue Hartford, Connecticut 06105 and is the owner of the right, title and interest in, to and under the following mark owned by Assignor and used or held for use in the business and operations of the Stations (the "Mark"):

**WHEREAS**, Assignee is a California non-profit corporation having its principal office at 5700 West Oaks Blvd, Rocklin, CA 95765 and desires to acquire the Mark.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to the Purchase Agreement, Assignor hereby transfers, assigns, conveys and delivers to Assignee, its successors and assigns, Assignor's right, title and interest in, to and under the Mark (including the registrations thereof and applications therefor (wherever filed)), together with the goodwill, if any, associated with the use of the Mark, free and clear of liens, charges, claims or encumbrances (other than Permitted Liens).

This Assignment shall be governed, construed, and enforced in accordance with the laws of the State of Delaware, but without regard to the choice of laws provisions thereof, and any action or proceeding arising out of this Assignment shall be brought and maintained in Connecticut, without any regard to any conflict of law provisions. Assignee and Sellers consent to the jurisdiction of the courts located in Connecticut.

This Assignment of Mark is made pursuant to (and does not modify) the Purchase Agreement. This Assignment of Mark is subject in all respects to the terms and conditions of the Purchase Agreement and does not (i) create any additional obligations, covenants, agreements, representations or warranties or alter, amend or supersede any of the obligations, covenants, agreements, representations or warranties of Assignee, Assignor or any other party thereto contained in the Purchase Agreement or (ii) expand upon or limit the respective rights, benefits,

responsibilities and obligations of Assignee, Assignor or any other party thereto provided in or under the Purchase Agreement. In the event the terms of this Assignment of Mark conflict with the terms of the Purchase Agreement, the terms of the Purchase Agreement shall govern. Capitalized terms used herein and not defined shall have the respective meanings set forth in the Purchase Agreement.

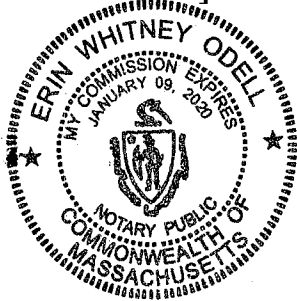
