**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (the "Release") is executed as of November 18, 2014, by Deutsche Bank AG New York Branch, as Collateral Agent under the Credit Agreement referred to below (in such capacity, the "Collateral Agent"), in favor of LSI Corporation (the "Grantor"). Unless otherwise indicated, capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Credit Agreement or Collateral Agreement as referred to below.

WHEREAS, reference is made to (a) that certain Credit Agreement dated as of May 6, 2014 (as amended, supplemented, or otherwise modified from time to time, the "Credit Agreement"), among Avago Technologies Finance Pte. Ltd., a company incorporated under the Singapore Companies Act, Avago Technologies Cayman Ltd., an exempted company incorporated with limited liability in the Cayman Islands, Avago Technologies Holdings Luxembourg S.à.r.l., a private limited liability company incorporated under the laws of Luxembourg, the Lenders party thereto and the Collateral Agent and (b) that certain Collateral Agreement dated as of May 6, 2014 (as amended, supplemented, or otherwise modified from time to time, the "Collateral Agreement"), with the grantors from time to time party thereto and the Collateral Agent; and

WHEREAS, the Grantor and the Collateral Agent executed a Trademark Security Agreement dated as of May 6, 2014 (as amended, supplemented, or otherwise modified from time to time, the "Trademark Security Agreement") pursuant to which the Grantor granted to the Collateral Agent a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined therein) (the "Security Interest"), including the Trademarks listed on Exhibit A hereto, in order to induce the Lenders to make additional Loans and as consideration for Loans previously made; and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 8, 2014 at Reel 5276 and Frame 0262; and

WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest solely with respect to the Trademarks listed on Exhibit A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Collateral Agent hereby releases, terminates and discharges the Security Interest granted under the Trademark Security Agreement solely with respect to the Trademarks listed on Exhibit A hereto, and any right, title or interest of the Collateral Agent in such Security Interest granted under the Trademark Security Agreement solely with respect to the Trademarks listed on Exhibit A hereto shall hereby terminate, cease and become void. The Collateral Agent hereby consents to the recording of this Release with the United States Patent and Trademark Office and agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest solely with respect to the Trademarks listed on Exhibit A as contemplated hereby.
