## RELEASE OF SECURITY INTEREST

This RELEASE, dated as of November 21, 2014 is made by U.S. BANK NATIONAL ASSOCIATION (AS SUCCESSOR TO WACHOVIA BANK, NATIONAL ASSOCIATION), AS COLLATERAL AGENT, a national association (“U.S. Bank”), with reference to certain trademark security agreements executed by TENNECO INC., a Delaware corporation, TENNECO AUTOMOTIVE OPERATING COMPANY INC., a Delaware corporation, TENNECO INTERNATIONAL HOLDING CORP., a Delaware corporation, TENNECO GLOBAL HOLDINGS INC., a Delaware corporation, THE PULLMAN COMPANY, a Delaware corporation, TMC TEXAS INC., a Delaware corporation, and CLEVITE INDUSTRIES INC., (collectively, “Tenneco”) in favor of U.S. Bank (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreements”) pursuant to Tenneco’s 10¼% Senior Secured Notes due 2013 under that certain Third Supplemental Indenture dated June 19, 2003, which were recorded with the United States Patent and Trademark Office on:

1. April 27, 2006, at reel and frame number 3298/0397.

Capitalized terms not defined in this Release shall have the meanings set forth in the Trademark Security Agreements.

For good and valuable consideration, receipt of which is hereby acknowledged, U.S. Bank hereby:

1. releases the security interest granted to U.S. Bank by Tenneco with respect to all Trademarks described in the Trademark Security Agreements, including, but not limited to, the Trademarks listed on Exhibit A attached hereto (collectively, the “Tenneco Trademarks”); and

2. to the extent U.S. Bank shall be deemed to have any right, title or interest in the Tenneco Trademarks, retransfers and reassigns to Tenneco all of such right, title and interest without representation or warranty of any kind whatsoever.

U.S. Bank hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other governmental official record this Release. This Release shall be governed by the laws of the State of New York.


